

OFFICIAL RULES FOR THE LOGMEIN GOTO PORTAL FROM FACEBOOK SWEEPSTAKES

NO PURCHASE REQUIRED TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING A PRIZE. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

- 1. **SPONSOR:** The Promotion is sponsored by LogMeln USA, Inc. 320 Summer Street, Boston, MA 02210 ("LogMeln").
- 2. **ELIGIBILITY**: The LogMeIn GoTo Portal from Facebook Sweepstakes (the "Promotion") is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years of age or have reached the age of majority in their jurisdiction of residence. Employees of LogMeIn USA, Inc., its affiliates and companies associated with the advertisement and marketing of the Promotion, as well as the immediate family and household members of each employee of the foregoing companies are not eligible. Participation in the Promotion constitutes your full and unconditional agreement to and acceptance of these Official Rules. LogMeIn's decisions with respect to the Promotion are final and binding. Winning a prize is contingent upon fulfilling all requirements set forth herein.
- 3. **ENTRY PERIOD:** The Promotion begins at 9:00 am ET on October 20 and ends at 5:00 pm ET on November 6, 2020 (the "Entry Period"). Entries that are submitted before or after the Entry Period will be disqualified.
- 4. **How to Enter:** Each week on GoTo's <u>Twitter, LinkedIn, Facebook</u> and <u>Instagram</u> pages, over the course of three weeks, there will be an open-ended question put forth that will be identified by GoTo as the sweepstakes entry question for that week. To enter the promotion for week one, you must answer the sweepstakes question posed on 10/27/2020 on one or all of GoTo's pages (Twitter, LinkedIn, Facebook and Instagram) and tag someone that has a page on whichever platform you respond on that you enjoy video chatting with. To enter the sweepstakes during week two, you must answer the sweepstakes question posed by GoTo on 11/3/2020. You may enter once per platform per weekly question (Twitter, LinkedIn, Facebook and Instagram), totaling 4 entries per week. Additional answers may be permitted, but will not be counted as additional entries.

Incomplete or piecemeal submissions WILL NOT BE ACCEPTED as entries and shall not be eligible for any prize.

- 5. **WINNER SELECTION AND NOTIFICATION:** One winner and their tagged "video chat BFF" (noted in the sweepstakes question for the week) will be chosen by random drawing at 5:00 pm ET on October 23, 2020 for the first week. If a friend is not tagged, the entry is void. The winner will be chosen by random drawing from entries across Facebook, LinkedIn, Twitter and Instagram. For the second week, 4 winners will be chosen by random drawing at 5:00 pm ET on October 30, 2020. One winning answer will be randomly selected from Facebook, one from LinkedIn, one from Twitter and one from Instagram during the second week. The winners will be notified via direct message to the profile used on the social platform they entered on. No one person can win more than one prize. Winners must acknowledge and respond to any direct message notice within _2_ days of the date of notification or LogMeIn reserves the right to award a prize to the next runner up in the Promotion. No other notice will be provided. LogMeIn shall have no liability for any prize winning notification that is lost, intercepted or not received by any prize winner for any reason. If any prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines a prize for any reason prior to award, such prize winner will be disqualified, and an alternate prize winner may be selected.

FOUR WINNERS AT THE END OF WEEK 2 WILL EACH RECEIVE A FACEBOOK PORTAL (EACH WORTH \$179.00). Prizes are non-transferable and cannot be substituted for like value. LogMeIn reserves the right to substitute a prize of equal or greater value in the event a prize is not available at the time of award.

- 7. **ODDS OF WINNING.** The odds of winning depend upon the number of eligible entries received during the Entry Period.
- 8. **ADDITIONAL REQUIREMENTS OF PRIZE WINNERS AND SOME ENTRANTS:** Except where prohibited, Winners and some Entrants will be required to expressly consent to the use of their name(s), image(s) and likeness(es) identifying them as winners of this promotion before receiving a prize. In addition, except where prohibited, LogMeIn may require Entrants and Winners to sign and return an affidavit of eligibility, and a liability/publicity release ("Affidavit and Release"). The Affidavit and Release will be provided separately if it is required. All documents requested by LogMeIn, including the Affidavit and Release must be signed, notarized, and returned to LogMeIn within 14 days of receiving notice. Failure by LogMeIn to enforce any provision of these Official Rules shall not constitute a waiver of that provision. The Promotion is subject to federal, state, and local laws and regulations and is void where prohibited. In the event of a dispute as to the owner of an Entry, the authorized account holder of the e-mail address used to enter will be deemed to be the Entrant. The "authorized account holder" is the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.
- 10. **Assignment of Rights; Release and Walver of Claims:** By participating, you assign to LogMeln all right, title and interest in and to the Entry without any compensation. Your submission of an Entry and assignment of rights to LogMeln constitutes your express acknowledgement that LogMeln, its agents, licensees and assigns have the unconditional right and permission to reproduce, display, publish, publicly perform, modify, create derivative works from, and otherwise use your Entry for any purpose in any media throughout the world, without any requirement for additional review, compensation, or approval. 12. **RELEASE AND LIMITATION OF LIABILITY**: LogMeIn shall not be liable for any claims, demands, damages and causes of action or any costs or expenses relating to the foregoing, arising out of or relating in any way to the Promotion or any prize. By participating in this Promotion, you hereby release and discharge the LogMeIn Entities from any and all claims, demands, damages and causes of action of every kind and nature, in law, equity or otherwise, known and unknown, suspected and unsuspected, disclosed and undisclosed, and in particular any from all claims, demands, damages and causes of action of every kind and nature for damages actual and consequential, past, present, and future, arising out of, or in any way relating the Promotion, the administration of the Promotion, any prize awarded, the use or misuse of any prize, and any publicity, advertising or promotion relating to the Promotion and/or the prize, and/or acceptance, possession, use, or misuse of the prize. Section 1542 reads as follows:

"Section 1542. (<u>General Release - Claims Extinguished.</u>) A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor."

- 13. **DISPUTES:** Except where prohibited, you agree that any and all disputes, claims and causes of action arising out of, or connected with, the Promotion or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the Commonwealth of Massachusetts. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, your rights and obligations, or the rights and obligations of LogMeIn in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of Massachusetts, without giving effect to any choice of law or conflict of law rules (whether of Massachusetts or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than Massachusetts.
